2.1 Announcements

2.1.1 New USPS APIs Platform

1. Summary: New USPS APIs are available on the USPS Developer Portal. The new platform offers more API customization, product offerings, and payment options. Additional features include increased security via OAuth 2.0 authentication. Visit <https://developers.usps.com> for details.

2.2 Production Release: January 16, 2025

External testing: Jan. 7

The API changes noted below will be released to production in the late-night hours of January 16, 2025. USPS is enacting a Price Change on January 19, 2025, which will be available on January 16 when using a ship date of January 19 or beyond. All domestic and international price calculator and shipping label APIs will reflect updated pricing in XML responses, on shipping label images, and in the Shipping Services Files (see Appendix A for full list of price calculator and label APIs). To test updated prices, use a ship date of 1/19/25 or later in our lower testing environments.

Changes beyond basic price updates are explained below, per API.

2.2.1 Saint Pierre and Miquelon Country Price Group Updates

1. Summary: Saint Pierre and Miquelon will mirror pricing for parent country France for a subset of categories including Priority Mail International (PMI), First-Class Mail International (FCMI), First-Class Package International Service (FCPIS), and International Priority Airmail (IPA). Reference USPS Notice 123 for details <https://pe.usps.com/PriceChange>.
 - Impacted APIs:
 - International Price Calculator API (API=IntlRateV2)

- Customs Form CP72 International Label API (API=CustomsCP72V3)
- New Saint Pierre and Miquelon country price groups:
 - Priority Mail International (PMI) will be 15.
 - Flat Rate Envelopes and Boxes will be 4.
 - First-Class Mail International (FCMI) will be 5.
 - First-Class Package International Service (FCPIS) will be 15.
 - International Priority Airmail (IPA) will be 15.

2.2.2 HAZMAT - PTFAS Shipping Restrictions Updates

1. Summary: Possessions, Territories, and Freely Associated States (PTFAS) locations will support a limited list of HAZMAT options (i.e., extra service codes) eligible for shipping except for Puerto Rico (PR) which will continue to support all HAZMAT options (i.e., ESCs 810-832). Only three HAZMAT options (i.e., ESCs) listed below will be supported for PTFAS locations excluding Puerto Rico:
 - 813 (HAZMAT Class 7 - Radioactive Materials Package)
 - 820 (HAZMAT Class 9 - Lithium batteries, unmarked package)
 - 826 (HAZMAT Division 6.2 - Infectious Substances Package)
2. Impacted APIs:
 - Domestic Price Calculator API (API=RateV4)
 - Internal Package Intercept Label API (API=InterceptLabel)
 - USPS Returns Label API (API=USPSReturnsLabel)
 - eVS Domestic Label API (API=eVS)

2.2.3 HAZMAT - APO/FPO/DPO+PTFAS Label Updates

1. Summary: Web Tools will update HAZMAT labels (both domestic labels and domestic customs forms) for APO/FPO/DPO+PTFAS locations (excluding Puerto Rico) to remove all HAZMAT identifiers on the labels.
 - Impacted APIs:
 - USPS Returns Label API (API=USPSReturnsLabel)
 - eVS Domestic Label API (API=eVS)
2. Label API Updates:
 - Puerto Rico (PR) HAZMAT labels will not change.
 - HAZMAT labels without an APO/FPO/DPO+PTFAS location will not change.
 - APO/FPO/DPO+PTFAS locations (excluding PR) with HAZMAT will use a regular/non-HAZMAT Service Type Code (STC) in the barcode, on the label, and in the SSF.
 - Example: STC 385 (USPS Ground Advantage Return One Pound or More Hazardous Materials) used currently will change to STC 022 (USPS Ground Advantage Return One Pound or More).
 - Web Tools will pass the HAZMAT extra services (ESCs) collected in the request in the Shipping Services File (SSF) D1 pos. 44 Extra Service Code fields.
 - HAZMAT general ESC “857” will be included with applicable HAZMAT specific ESCs (i.e., 810-832).
 - APO/FPO/DPO+PTFAS locations (excluding PR) with HAZMAT where a domestic label returns (i.e., customs form is not required) will have the following additional label image updates:
 - HAZMAT “H” service icon will be updated to normal service icon.
 - “HAZMAT – Surface Transportation Only” endorsement will be removed.
 - HAZMAT STC banner text will be updated to reflect regular/non-HAZMAT banner text.

2.2.4 HAZMAT - New Service Type Codes (STCs)

1. Summary: Web Tools will update impacted APIs to support new HAZMAT service type code (STC) options STC 121 (Priority Mail Adult Signature Over 21 Restricted Delivery Hazardous Materials) and STC 665 (Priority Mail Express Adult Signature Over 21 Restricted Delivery Hazardous Materials).

- Impacted APIs:
 - Domestic Price Calculator API (API=RateV4)
 - USPS Returns Label API (API=USPSReturnsLabel)
 - eVS Domestic Label API (API=eVS)
- 2. Domestic Price Calculator API (API=RateV4) Updates:
 - STC 121 (Priority Mail Adult Signature Over 21 Restricted Delivery Hazardous Materials) will return as CLASSID="4010" (Priority Mail<sup>®</sup> HAZMAT) with <SpecialService>="120" (Adult Signature Restricted Delivery) and applicable HAZMAT services ("810-832").
 - STC 665 (Priority Mail Express Adult Signature Over 21 Restricted Delivery Hazardous Materials) will return as CLASSID="4001" (Priority Mail Express X-Day<sup>®</sup> HAZMAT) with <SpecialService>="120" (Adult Signature Restricted Delivery) and applicable HAZMAT services ("810-832").
- 3. Domestic Label API Updates:
 - Domestic Label APIs will support HAZMAT and Adult Signature Restricted Delivery with Priority Mail Express and Priority Mail when available.
 - New STCs will return in the barcode, label, and Shipping Services File (SSF).

2.2.5 Elimination of Return Receipt for PMI Parcels and FCPIS

1. Summary: Priority Mail International (PMI) parcels and First-Class Package International Service (FCPIS) will not support Return Receipt.
 - Impacted APIs:
 - International Price Calculator API (API=IntlRateV2)
 - eVS PMI International Label API (API=eVSPriorityMailIntl)
 - eVS FCPIS International Label API (API=eVSFirstClassMailIntl)
 - Return Receipt (i.e., extra service/special service "105") will not return for Priority Mail International (PMI) parcels and First-Class Package International Service (FCPIS).

2.2.6 Parcel Processing – “Nonstandard” Updates

1. Summary: USPS will simplify parcel processing categories by combining the current “Nonmachinable” and “Irregular” categories into a single “Nonstandard” category. Web Tools APIs will be updated to support Machinable and Nonstandard (replacing Nonmachinable and Irregular) categories for parcels. Note: Letters and Flats are not impacted; only parcels.
 - Impacted APIs:
 - Domestic Price Calculator API (API=RateV4)
 - All Domestic Label APIs (reference Appendix A section 3.1.3)
2. Domestic Price Calculator API (API=RateV4) Updates:
 - Mail Class descriptions containing "Irregular" and "Nonmachinable" will be replaced with "Nonstandard".
 - Example: “USPS Marketing Mail Irregular Parcels” (CLASSID="81") will be updated to “USPS Marketing Mail Nonstandard Parcels”
3. Domestic Label API Updates:
 - Where <Machinable> request tag supports an enumeration of “Irregular”, this value will be deprecated but remain backwards compatible and handled as “Nonstandard”. New “Nonstandard” enumeration will be added. Integrators will also be able to pass current “false” enumeration to indicate “Nonstandard.”
 - Shipping Services File (SSFv2.0) D1 pos. 36 Processing Category field value of "4" (Irregular) will be eliminated and replaced with "5" (“Nonstandard”, formerly "Nonmachinable").
 - Shipping Partner Event File (SPEV5.0) 548-548 Processing Category field value of "4" (Irregular) will be eliminated and replaced with "5" (“Nonstandard”, formerly "Nonmachinable").

2.2.7 USPS Connect Local Mail Updates

1. Summary: USPS will establish USPS Connect Local Mail as a permanent product. Web Tools will update impacted APIs to support the permanent product. Reference USPS Notice 123 for details <https://pe.usps.com/PriceChange>.
 - Impacted APIs:
 - Domestic Price Calculator API (API=RateV4)
2. Domestic Price Calculator API (API=RateV4) Updates:
 - New <Service> enumeration of "CONNECT LOCAL MAIL"
 - API response CLASSID and Mail Service description field values will be updated to support permanent product:
 - New <Postage CLASSID="1093">
 - New <MailService> value of "USPS Connect Local Mail"

2.2.8 New Lives/Perishable Handling Fee Updates

1. Summary: USPS will implement new handling fees for packages containing Lives or Perishable contents. Reference USPS Notice 123 for details <https://pe.usps.com/PriceChange>. The current Live Animal Transportation fee of \$0.20 per pound of Day-Old Poultry still exists and will be charged in addition to these new fees if/when applicable.
 - Impacted APIs:
 - Domestic Price Calculator API (API=RateV4)
 - eVS Domestic Label API (API=eVS)
 - New Lives/Perishable Handling Fees per mail class:
 - Priority Mail Express = \$7.50
 - Priority Mail = \$15.00
 - Ground Advantage = \$7.50
2. Domestic Price Calculator API (API=RateV4) Updates:
 - When <ContentType>="PERISHABLE" or "LIVES", the new handling fees will return when applicable.
 - The new fees will be reflected in postage amount returned in <Rate>, <CommercialRate>, and <CommercialPlusRate> tags.
 - The new fees will return in the <Fees> response node when <ReturnFees>="true" is included in the API request.
 - New Perishable Fee will return as <FeeType>Perishable Handling Fee</FeeType>
 - New Lives Fee will return as <FeeType>Live Animal Handling Fee</FeeType>
 - Current Lives Transportation Fee returned as <FeeType>Live Animal Transportation fee</FeeType> will not change.
 - Reference Appendix B for sample XML requests/responses.
3. Domestic Label APIs Updates:
 - When <ContentType>="PERISHABLE" or "LIVES", the new handling fees will return when applicable.
 - The new fees will be reflected in postage amount returned.
 - The new fees will return in the <Fees> response node when <ReturnFees>="true" is included in the API request.
 - New Perishable Fee will return as <FeeType>Perishable Handling Fee</FeeType>
 - New Lives Fee will return as <FeeType>Live Animal Handling Fee</FeeType>
 - Current Lives Transportation Fee returned as <FeeType>Live Animal Transportation fee</FeeType> will not change.
 - When the new fees apply, Web Tools will include "972" in the Shipping Services File (SSFv2.0) D1 pos. 44 Extra Service Code field and the applicable fee in the D1 pos. 45 Extra Service Fee field.

2.2.9 Maintenance

1. Web Tools will implement 2025 Special Drawing Rights (SDR) values.

2. Updates to eVS FCPIS International Label API (API=eVSFirstClassMailIntl) to resolve a bug where the <ToPhone> value printed on the label is narrowed when Importer's Reference Number is not printed. Fix will make <ToPhone> value more legible.
3. Updates to Domestic Price Calculator API (API=RateV4) to improve error messaging returned when a hyphen is supplied in the dimensions (<Length>, <Width>, <Height>, etc.) request tags.
4. Updates to International Price Calculator API (API=IntlRateV2) to resolve errors returning when an asterisk is supplied in the <DestinationPostalCode> request tag.

2.3 Production Release: February 20, 2025

External testing: Feb. 6

2.3.1 Web Tools Maintenance Outage Impacting All APIs – Effective Feb. 13 9pm ET

1. Summary: A planned maintenance outage impacting all Web Tools APIs will occur Thursday February 13, 2025, at 9pm ET for approximately 15 minutes. During this time, integrators could see errors or potential degraded API performance.

2.3.2 PO Box Locker Updates

1. Summary: Web Tools will make updates to impacted APIs to enable shipping to a PO Box locker.
 - o Impacted APIs:
 - Locker Lookup API (API=GetLockerInfo)
 - eVS Domestic Label API (API=eVS)
 - Address APIs (APIs=Verify, ZipCodeLookup, etc.)
2. Locker Lookup API (API=GetLockerInfo) Updates:
 - o The API will return facilities that support PO Box Lockers.
 - o The PO Box locker delivery address will return in the <DeliveryAddress> response tags.
 - o New optional <Revision> request tag will be added. A value of "1" will result in new <LockerType> tag returning in response with values of "SmartLocker" or "POBoxLocker"
 - If <Revision>="1" not included in the request, <LockerType> tag will not return to maintain backwards compatibility.
 - o Reference Appendix B for sample API request/response.
3. eVS Domestic Label API (API=eVS) Updates:
 - o The PO Box delivery address will be returned in the <ParcelLocker> response tags and used as destination address on the label and receipt.
 - o The label banner will display "DELIVER TO PO BOX LOCKER"
 - o Reference Appendix B for sample label.
4. Address APIs Updates (APIs=Verify, ZipCodeLookup, etc.)
 - o The API(s) will allow users to search for a PO Box locker address (i.e., "PO BOX LOCKER" as primary street address).

2.3.3 Maintenance

1. Effective Feb. 13, backend updates to implement latest AMS library data impacting all Address and Label APIs. No structural XML request/response changes.
2. Updates to Web Tools Registration email to reference developers.usps.com.

2.4 Production Release: March 27, 2025

External testing: Mar. 13

2.4.1 Service Standards Updates

1. Summary: Web Tools APIs will be updated to support updated service standards for First-Class Mail (FCM) Commercial presort options. Reference <https://pe.usps.com/> for additional details.
 - o Impacted APIs:
 - Domestic Price Calculator (API=RateV4)

- Service Standards APIs (APIs=SDCGetLocations, FirstClassMail)
 - Domestic Price Calculator (API=RateV4) Updates:
 - Updates to enable FCM Commercial Flats to return:
 - Updates will resolve errors when <Service>="FIRST CLASS COMMERCIAL" and <FirstClassMailType>="FLAT" are included in the API request.
 - Updated FCM presort flats and postcard service standards will return in "Commitment" tags for the following API inputs:
 - <Service>="FIRST CLASS COMMERCIAL", "ONLINE"
 - <FirstClassMailType>="POSTCARD", "FLAT"
 - <SortationLevel>="PST" (presort)
 - <ShipDate>
 - Reference USPS Notice 123 <https://pe.usps.com/text/dmm300/Notice123.htm> for FCM Commercial postcard and flat presort pricing details.
 - Service Standards APIs (APIs=SDCGetLocations, FirstClassMail) Updates:
 - New optional tag <SortationLevel> will be added with value "PST" (presort) to indicate presort service standards for First-Class Mail (FCM).
 - When indicated in the request the tag will echo in the API response (i.e., <SortationLevel>PST</SortationLevel>).
 - Applicable with FCM <MailClass> values:
 - "301" (FCM Letters)
 - "302" (FCM Flats)
 - "303" (FCM Cards)
 - Reference Appendix B for sample XML request/response.
- ~~2. Summary: The Web Tools Service Standards API (API=SDCGetLocations) will be updated to support Parcel Select Destination Entry service standards.~~
- ~~○ A value of "7" for <MailClass> will be updated to return PSDE service standards.~~

2.4.2 Maintenance

1. Backend updates to Domestic Price Calculator API (API=RateV4) to improve performance time when multiple packages are included in a single API request.
2. Backend updates to Domestic Label APIs (reference Appendix A) to improve performance when customers opt into generating a delivery confirmation email when creating a shipping label.
3. Backend updates to Domestic and International Label APIs (reference Appendix A) to improve interface with Zonos when customs information is required to reduce timeouts and degraded performance issues.
4. Updates to eVS Domestic Label API (API=eVS) to improve distortions on ZPL label images.
5. Updates to Service Standards API (API=SDCGetLocations) to suppress invalid date value of "0001-01-01" returning in <ScheduledDeliveryDate> tag for military locations when a commitment date does not exist. The <ScheduledDeliveryDate> tag will continue to return in the XML response, but the value returned will be null/blank to maintain backwards compatibility.

2.5 Production Release: April 24, 2025

External testing: Apr. 21

2.5.1 eVS Domestic Label API Updates (API=eVS)

1. Summary: Web Tools will update the eVS Domestic Label API (API=eVS) to support new Global Direct Entry (GDE) Service Type Code (STC) combinations.
 - Integrators configured for GDE will see new STCs used in the barcode when the appropriate mail class is passed in the <ServiceType> request tag and extra service is passed in the <ExtraService> request tag.
 - Note: The deadline for eVS Label API integrators to migrate to the new USPS APIs has passed. Integrators should migrate ASAP by contacting their USPS Account Representative and reference <https://developers.usps.com/> for more details.

2.5.2 Maintenance

1. Additional backend updates to Domestic Price Calculator API (API=RateV4) to improve performance time when multiple packages are included in a single API request.
2. Fixes to Domestic Price Calculator API (API=RateV4) to resolve First-Class Mail Commercial Flat Presort commercial postage price returning in the incorrect retail <Rate> tag. Updates will result in postage returning in correct <CommercialRate> response tag.
3. Fixes to Domestic Price Calculator API (API=RateV4) to return First-Class Commercial Mail automation options.
4. Fixes to Domestic Price Calculator API (API=RateV4) to return commitments when available for Parcel Select Destination Entry (PSDE).
5. Fixes to Domestic Price Calculator API (API=RateV4) and USPS Returns Label API (API=USPSReturnsLabel) to remove Nonstandard Fees which do not apply to returns.
6. Fixes to Domestic Price Calculator API (API=RateV4) and Domestic Label APIs (Reference Appendix B) to resolve incorrect HAZMAT options returning for Hawaii Zip Codes (i.e., 96791).

2.6 Production Release: May 29, 2025

External testing: May 19

2.6.1 Service Standard Updates (API=SDCGetLocations)

1. Summary: Web Tools will update the Service Standards API (API=SDCGetLocations) to support Parcel Select Destination Entry (PSDE) commitments.
 - New optional tag <DestinationEntryFacilityType> will be added to collect entry location used to calculate commitments for PSDE.
 - Updates will be backwards compatible.
 - Values:
 - Destination Delivery Unit: "DDU"
 - Destination Hub: "DHUB"
 - Destination Sectional Center Facility: "DSCF"
 - Destination Network Distribution Unit: "DNDC"
 - A <MailClass> value of "7" (Parcel Select) and <DestinationEntryFacilityType> will return Parcel Select Destination Entry (PSDE) commitments.
 - Note: PSDE commitments require a destination entry location to be specified. If a <MailClass> value of "7" (Parcel Select) is provided without an <DestinationEntryFacilityType> specified, commitments will return for USPS Ground Advantage (1 to 70lbs) equivalent to <MailClass> value of "9".
 - Reference Appendix B for sample API request.

2.6.2 Maintenance

1. Effective 5/14/25, fixes to Domestic Rate Calculator API (API=RateV4) to restore missing commitment values for Marketing Mail Parcel.
2. Effective 5/15/25, fixes to Domestic Rate Calculator API (API=RateV4) to restore incorrect Marketing Mail Parcel prices.
3. Effective 5/15/25, fixes to Domestic Price Calculator API (API=RateV4) and eVS Domestic Label API (API=eVS) to resolve errors returning for Parcel Select Destination Entry (PSDE) HAZMAT.
4. Effective 5/15/25, fixes to International Price Calculator API (API=IntlRateV2) to resolve errors returning when "+" value included in any request tag.
5. Effective 5/15/25, backend updates to Address and Label APIs to update the address standardization and validation library to latest version.
6. Updates to Web Tools API authorization and authentication error messages to improve security.

2.7 Production Release: July 2, 2025

External testing: Jun. 25

The API changes noted below will be released to production in the late-night hours of July 2, 2025. USPS is enacting a Price Change on July 13, 2025, which will be available on July 2 when using a ship date of July 13 or beyond. All domestic and international price calculator and shipping label APIs will reflect updated pricing in XML responses, on shipping label images, and in the Shipping Services Files (see Appendix A for full list of price calculator and label APIs). To test updated prices, use a ship date of tomorrow in our lower testing environments.

2.7.1 USPS Nonstandard Fee Expansion
