

# Postal Bulletin Subscriptions

## Background

The *Postal Bulletin* is the official record of changes in Postal Service policies and procedures, and it is the vehicle for time-sensitive instructions and advance notice of changes in other directives. It is published biweekly and is effective for one year unless otherwise specified.

Postal Bulletin articles originate from Headquarters departments and are cleared and approved according to Management Instruction (MI) AS-310-96-3, *Management of Policy and Procedure Information - Paper and On-Line*. Field offices wishing to publish an article in the *Postal Bulletin* should contact their Headquarters vice president or designated representative.

## Distribution and Ordering Instructions

### *Postal Service Subscriptions*

- H **Regular subscriptions:** Any Postal Service facility can subscribe to the *Postal Bulletin* at no charge.
- H **Missing issues:** To replace missing copies or get back issues (stocked for 1 year), call MDC Customer Service at 800-332-0317.
- H **Subscription changes:** To change your address or quantity, send an e-mail to the address *Postal Bulletin*. Be sure to include the old and new address or quantities. If you do not have access to e-mail, call the *Postal Bulletin* subscription line at 703-292-3655.

### *Public Subscriptions*

Anyone in the public may subscribe to the *Postal Bulletin* or order single copies.
